






Location

Old Bank House is located on Devizes Road in the heart of Old Town, close to the junction with Wood Street, Bath Road and Victoria Road.



Description



Accommodation

The second floor office suite has been measured in accordance with the International Property Measurement Standard 3- Offices, and provides approximately 803 sq.ft. with 12 workstations.

There are 3 allocated on site car parking spaces with the suite.



Lease Terms

The office suite is available on a Licence Agreement for a minimum period of 6 months. Rent is paid monthly in advance with a 2 month rental deposit. The quoting rent, which is all inclusive, for the suite is £2,000 per month.
