

The property is of steel portal frame construction with part brick and part insulated metal-clad elevations. The warehouse areas are lit and are accessed via a full height roller shutter door.

Location

Monckton Road Industrial Estate is conveniently located approximately one mile to the north west of Junction 39 of the M1 motorway.
