## Location

The subject site is located to the North of Prestatyn Town Centre at the corner junction of Victoria Road with Marine and Bastion Roads. The immediate area is predominantly residential with other uses including retail and roadside. The junction of A548 with B5120 forms the main access way into Prestatyn town centre and is situated near to the towns railway station.

Prestatyn has an established vibrant town centre which includes a large number of multi-national occupiers including Marks & Spencer, River Island, Next, TK Maxx, Sports Direct, Boots and Poundland.

## Description & Accommodation

The subject site is occupied as a training and defence facility and comprises a total of approximately 1.9 acres (0.80 hectares). The accommodation onsite is constructed of brick elevations under part pitched part flat roof. The buildings are of 3 storeys to the front and single rear build, with front subdivided into offices, mess, barracks and ancillary space with rear providing open warehouse and stores facility. To the rear section of the site is a substantial yard area with rear grass land.

Gated vehicular access to the facility is provided off Marine Road with pedestrian access provided at the junction.
