LOCATION

Pretoria Industrial Estate in Besthorpe, is situated just north east of Attleborough and benefits from easy access on to the A11 dual carriageway.

Besthorpe is situated about 14 miles south west of Norwich and 17 miles north east of Thetford.

DESCRIPTION

The Pretoria Industrial Estate comprises a mix of medium to large Industrial/storage units of steel portal frame construction over concrete floors. Minimum eaves heights range from 13 ft on units 2, 3, 4 and 5, 16 ft on Unit 1 and 18 ft on Unit 9.

The units benefit from three-phase electricity, fluorescent/sodium lighting, and loading doors to shared concrete yards.

The units can be used for light or heavy industrial or storage use.
