

Location

An industrial premises of steel portal frame construction with low level brick/block to a height of approximately 2.5m surmounted by insulated profile sheet cladding to the upper walls and roof. New LED warehouse lights have been installed.

The roof had a slight pitch and incorporated translucent panels allowing natural daylight into the workshop area. Office accommodation has been provided at first floor level and the property has a dedicated yard area accessed from York Street.

The premises has a single access roller shutter measuring 3.21m wide by 4.3m high.
