Location

Scartho Top is a modern suburb to the south west of Grimsby close to the Diana, Princess of Wales hospital with access from Scartho Road. The area has seen significant residential development in recent years (approx. 1,500 new homes) with a further 700 new homes to be built in phases in the future.

The land forms part of the local centre and opportunity exists to develop the land to compliment the existing Aldi supermarket and Old Norse Lodge Care Home. In addition a retail centre and primary school are currently under construction.

Grimsby is the administrative centre for North East Lincolnshire and has a population of approx. 90,000 people with a wider catchment area including the neighbouring town of Cleethorpes and a number of outlying villages.

Description

The land is accessed from Matthew Telford Park and is bounded by the Old Norse Lodge Care Home to the north and an area of public open space to the south. The land is slightly irregular in shape and a sketch layout has been produced showing 16 residential properties being a mix of detached, semi-detached and link houses. Commercial uses will be considered on the site with potential uses including children's nursery, health related uses, retail and / or offices.
