## **Property**

The unit is of steel portal frame construction with insulated cladding to the roof and sides with full height curtain wall glazing to the front.

Internally the property is fitted with air conditioning, lighting, two separate wc's each of which are fitted with two shower cubicles and a wc, together with a further disabled wc. The unit is fitted with an electrically operated roller shutter door to the side elevation.

The property has an eaves height of approximately 5.095m.

There are a total of 50 car parking spaces which are shared with Units M1, M2 and M3 Welland Business Park, although 10 of these are demised to Unit M3.

### **Accommodation**

Having measured the property in accordance with the prevailing RICS Code of Measuring Practice, we calculate that it provides the following floor area.

In 2015 the property formed part of a successful change of use application (ref 15/01576/FUL) to divide a larger unit into three with change of use from B8 to three A1 non food bulky goods units. A further application was submitted on Unit M3 under (18/01884/FUL) for change of use from Class A1 to gymnasium (Class D2). All of these uses now fall under Class E of the Town and Country Planning (Use Classes) Order as amended September 2020



# Location

Welland Business Park is located on the A3404 Rockingham Road, less than one mile east of Market Harborough Town centre.

Rockingham Road is one of the main arterial roads into the town from the A6 Market Harborough bypass, the subject property sits towards the front of the Business Park with good visibility from Rockingham Road other retail trade counter users close by includes Tool Station, Tesco Express and Welland Valley Feeds and there is a new 14,000 sq.ft ALDI store currently under construction further along Rockingham Road.

Trade counter operators on the business park include Howdens, Paint Well, City Plumbing and Leoch Batteries with Topps Tiles, Screwfix and Travis Perkins being further along Rockingham Road.
