The property comprises a semi-detached industrial unit of brick construction with steel-clad elevations under a dual-pitched steel trussed roof.

The warehouse benefits from LED lighting, concrete flooring, WCs and a kitchenette. There is a dedicated parking / loading area to the front. The unit is to be fully cleared of stock and fittings.

LOCATION

The property is located on Lyon Road in a well established industrial location in South Wimbledon. The nearby A24 provides direct access into Central London and the M25 via the A3 dual carriage way.

South Wimbledon Underground Station (Northern Line) is located approximately 0.7 miles away and provides direct services into Central London. Morden Road tram stop is also located within 0.5 miles of the property, providing services to Croydon and Beckenham.


