The estate is located on Vestry Road, Sevenoaks, Kent close to Junction 5 of the M25. The location provides quick and easy access to the M20 approximately five miles to the East as well as access back into London via the M25/ A20.

These main arterial routes provide direct access to the national motorway network, M1 (J1), M25 (J25) and M11 (J4) and into Central London. Bat and Ball train station is a 15 minute walk to the estate.




