

HISTORY OF THE SITE





Broughton Hall was designed by Birkenhead architect, Walter Scott, and built for a prominent Liverpool merchant Gustov Schawbe of Hamburg.

It was designed and built around 1859 and was subsequently purchased by Alfred Turneran an East India Company merchant and sugar refiner. The Covent of Mercy purchased Broughton Hall in 1925 for use as a Roman Catholic Girls Secondary School by the Sisters of Mercy. Various detached extensions were built during the late 1930's and 1950's.

In 1968 / 1969 a new purpose built convent was constructed adjacent to the Hall, it was subsequently

converted into a care home. At that time part of the fish pond at the rear of the Hall was filled in at the northern end to provide green space around the new convent building. This property is currently occupied at ground level by the charitable organisation Zoe's Place Baby Hospice.

LOCATION

Broughton Hall is located in West Derby approximately 5 miles east of Liverpool City Centre. West Derby is an established residential suburb of Liverpool.

The property fronts Yew Tree Lane which leads to East Prescot Road (A57). Access to the M62 is approximately 2 miles south via Pilch Lane.

The immediate land use surrounding the Broughton Hall complex is a mixture of pre and post war semi-detached housing with Broughton Hall Catholic High School adjoining.

The historic West Derby Village is situated close by offering retail, restaurants and public houses.

Knowsley Hall, with it's vast estate sits at the edge of the village, built for the Earl of Derby. Today, it is still the home of the current Earl.



BROUGHTON HALL

The property comprises basement, ground, first and second floors. It is of stone construction with a steeply pitched slate roof with nine bay windows.


Internally, there is an entrance hall, reception, an impressive drawing room and dining room, some of which benefit from parquet floors and panelled oak walls and ceilings. There is a large imposing orangery.

The first floor is accessed from the main staircase adjoining the ground floor entrance offering lounge, 12 bedrooms, 12 dressing rooms and bathrooms. Lift access is also available.

ZOE'S PLACE BABY HOSPICE - FORMER CONVENT

Constructed in the late 1960's of frame construction with brick walls and flat roof.

Zoe's Place Baby Hospice occupy the ground floor. The upper floors are vacant and were used as residential accommodation when the building was used as a convent.

TENANCY

Liverpool's Zoe's Place are in occupation under a recently agreed lease for a fixed term until 30 June 2026, at a rent payable at £40,000 per annum.

This is occupied by way of an Assured Shorthold Tenancy (AST) since 2006 at a current rent of £390 pcm.








GARDENERS COTTAGE

TENURE

Broughton Hall is held freehold under Title Number: MS534497 and a small additional freehold title under Title Number: MS604545. The main title also includes the site of Broughton Hall Catholic High School which is to be retained.

A new fenced boundary has been installed and defines the extent of the school and the hall's respective sites. Final boundary works are taking place this summer to enclose the detached building south of the hall as part of the retained land, and the installation of a new barrier-controlled school entrance.

The school will retain ownership of the access from Yew Tree Lane with rights granted to the purchaser of the subject property.
