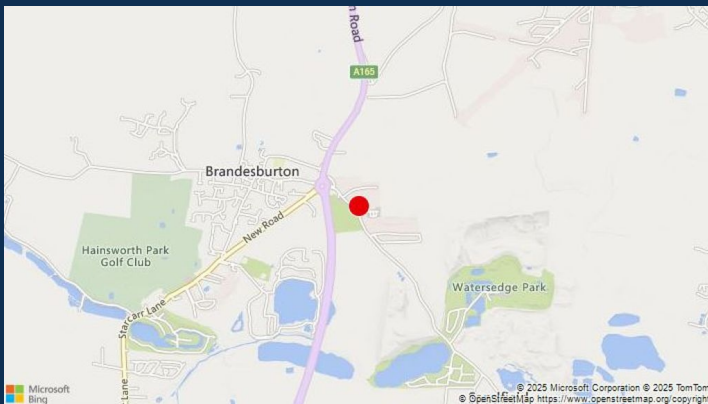

Location

The premises are located just off Catwick Lane, which is a short distance from the A165 which provides access to the east coast to the north, Hull and Beverley to the south.

Description

The property edged red on the main report image consists of a steel portal frame industrial unit with low level precast concrete retaining walls surmounted by insulated profile sheet cladding to the upper walls and roof. The property has a single access roller shutter at the front of the unit measuring 5.99 metres wide by 5.67 metres high. Internally the property benefits from low bay LED lighting discs and a three-phase electric supply with an apex of 7.14 metres and an eaves height of 6.06 metres.

The yard shown edged blue on the main report image consists of a compacted hardcore surface measuring approximately 0.3 acres.
