

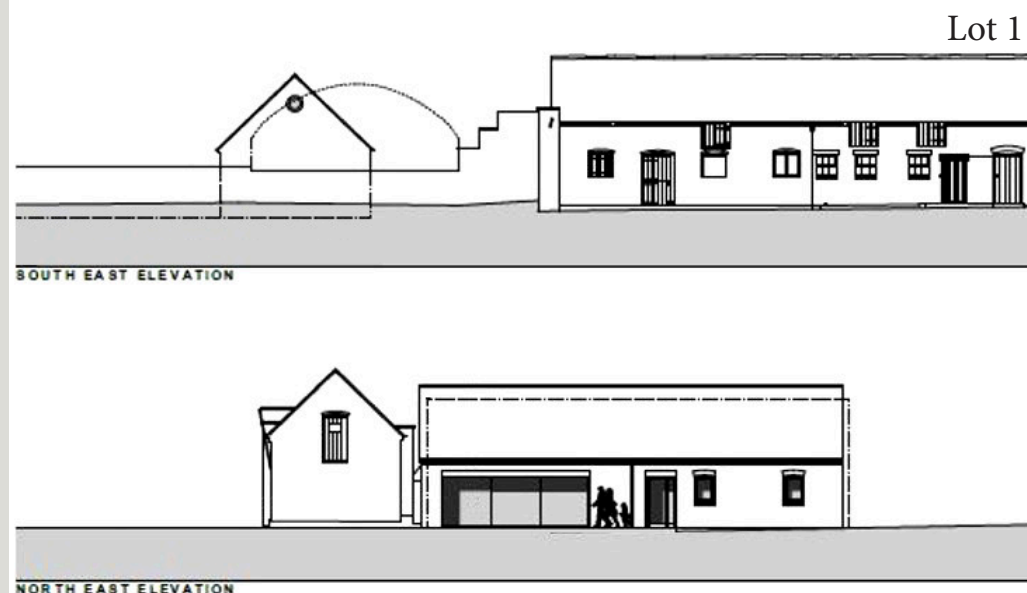

LOCATION

Gilbert's End Barn is located north of the village of Hanley Castle and is approximately 1.70 miles north west of Upton-upon-Severn, 4.05 miles to the south east of Malvern and 6.97 miles north west of Tewkesbury, in the county of Worcestershire.

Hanley Castle benefits from a popular secondary school and there are a range of services and amenities available close by in Malvern and Upton-upon-Severn.

Commuting links by road and rail are excellent with easy access to the M5 and M50 and there are regular trains in Malvern providing easy access to Worcester, Cheltenham and Birmingham.

DESCRIPTION

The property comprises an agricultural barn with planning consent under application M/24/00612/FUL for conversion to a 3 bedroom residential property.

There is a further 2.26 acres of arable land along with a modern open fronted agricultural building.

TENURE & POSSESSION

The Freehold is For Sale with Vacant Possession upon completion.

For Sale by Private Treaty as a whole or in up to two Lots.

LOT 1

An agricultural dutch barn with planning consent under M/24/00612/FUL for the conversion of the barn to a 3 bedroom residential property. This lot extends to approximately 0.20 acres of land and is shown shaded red on the plan.

LOT 2

Arable land with a modern open-fronted agricultural building. This lot extends to approximately 2.26 acres and is shown shaded blue on the plan.

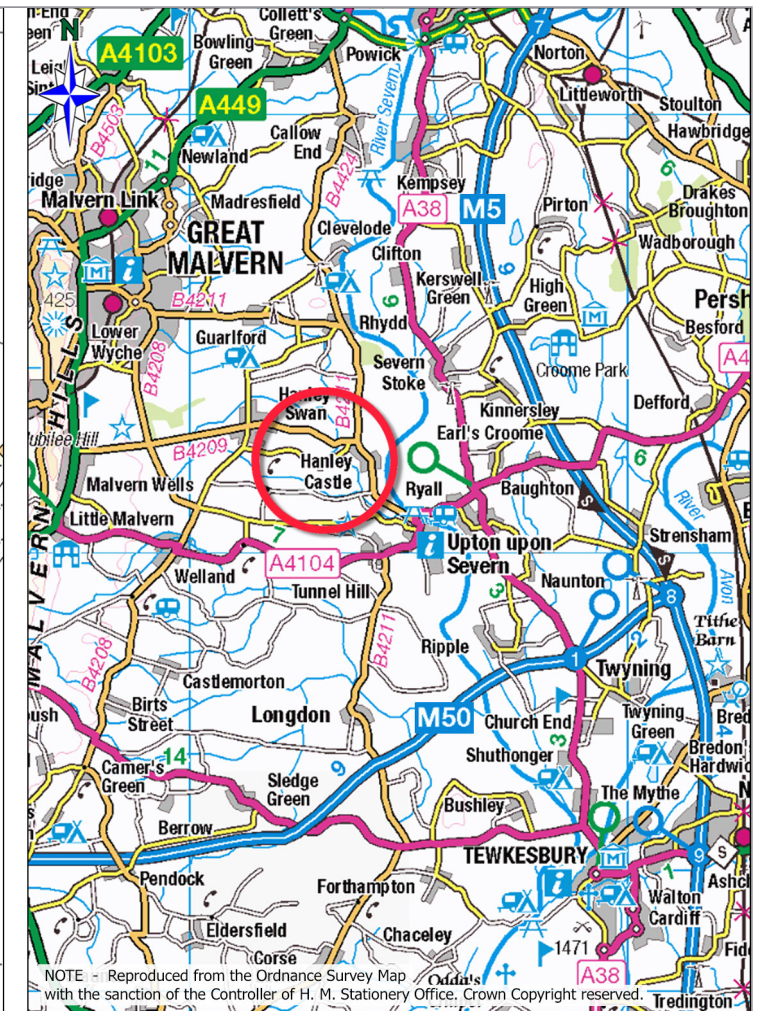
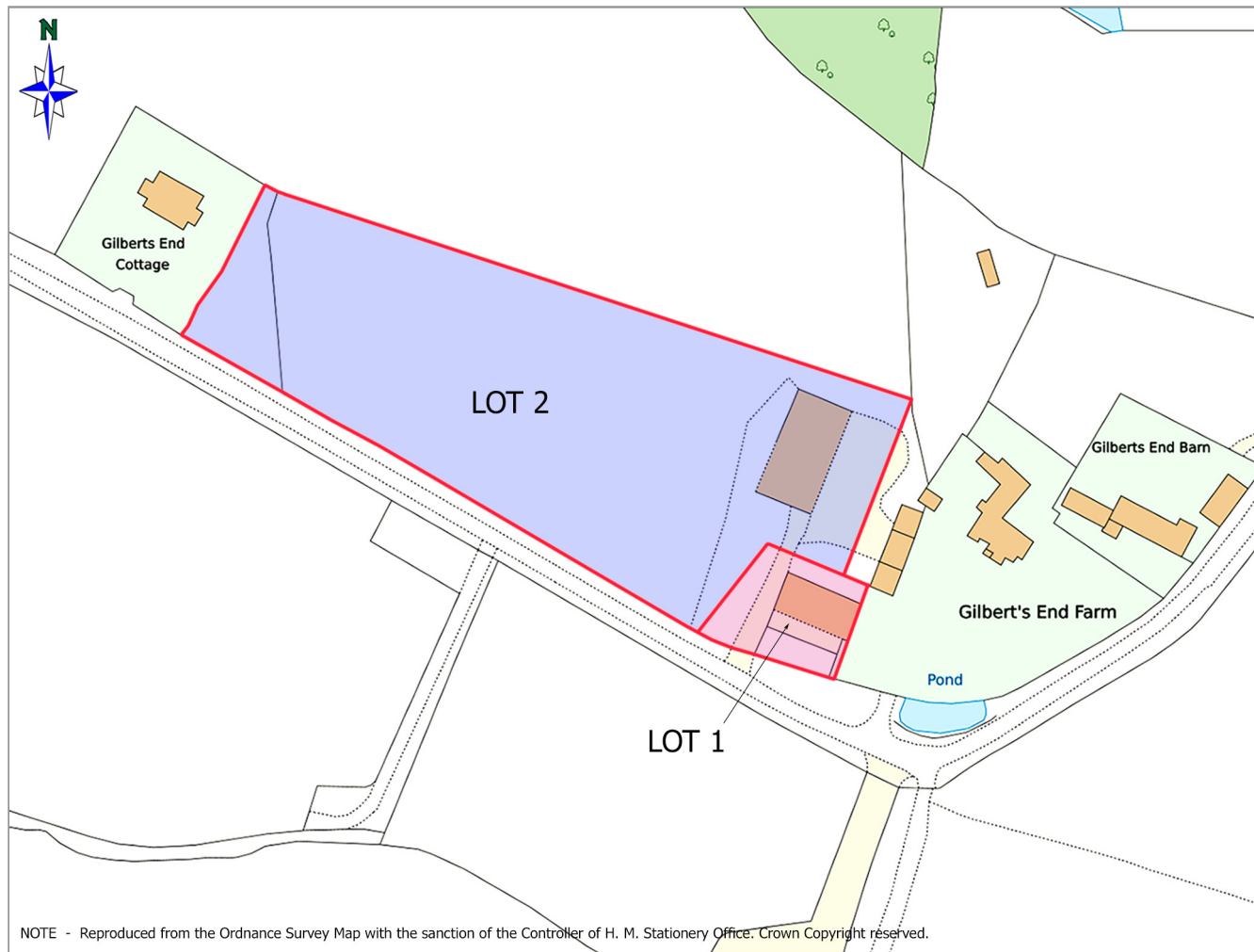
