## Location

The subject property is situated fronting Mansfield Road, which forms one of the key arterial routes out of Nottingham city centre to the north.

The property occupies a prominent position on Mansfield Road at the junction with Bluecoat Street.

Diagonally opposite the property is the entrance to Victoria Shopping Centre's 2,700 space car park and Victoria Bus Station.

Nottingham Trent University's city centre campus is a short walk away.

# **The Property**

The property comprises a retail showroom with extensive glazed frontage on the corner of Mansfield Road and Bluecoat Street in Nottingham city centre.

Internally, the accommodation is fully fitted as a retail showroom and is primarily open plan in configuration at both ground and mezzanine level.

In addition to the main sales areas there are staff toilets, kitchen, a glazed sales office and a rear store room which is suitable for a single car.

The property has an extensive frontage which benefits from full height glazing and allows for further signage opportunities.
