

The unit benefits from a full height sectional loading door, separate pedestrian entrance, small office with LED lighting, WC and three phase power. The current owenr has installed a mezzanine floor to approximately 3/4 of the unit providing additional storage space. Externally there is a loading apron and allocated parking for 2 vehicles




