### Location

The property is located in Market Square Newent. Newent is an attractive, expanding and thriving unspoilt town with a range of attractions for shoppers and visitors. Many of the buildings date from the thirteenth Century and the centrepiece of the town is the Old Market Hall which was built in 1668. The town is approximately 10 miles from Gloucester 9 miles from Ledbury and just 4 miles to Junction 3 of the M50.

### Description

The property is commercial property with a shop occupied by a tenant to the ground floor holding over on a standard commercial lease. The first floor is currently empty and the accommodation includes gas fired central heating, cupboard, Kitchenette, and WC facilities. The space lends itself to a variety of uses subject to necessary consents.

### Business Rates


