Holbury is a village in the county of Hampshire, forming part of the Parish of Fawley, on the edge of the New Forest. It is located on the west side of Southampton Water.

Holbury is approximately 13 miles south of Southampton and 12 miles from the M271 which gives access to the M27 and the wider motorway network. The land is located off The Close in Holbury, south west of Long Lane (A326).

Vacant mainly level parcel of land extending to 0.57 acres.
