Mottingham is located in Bromley, south-east London, within the London Borough of Lewisham.

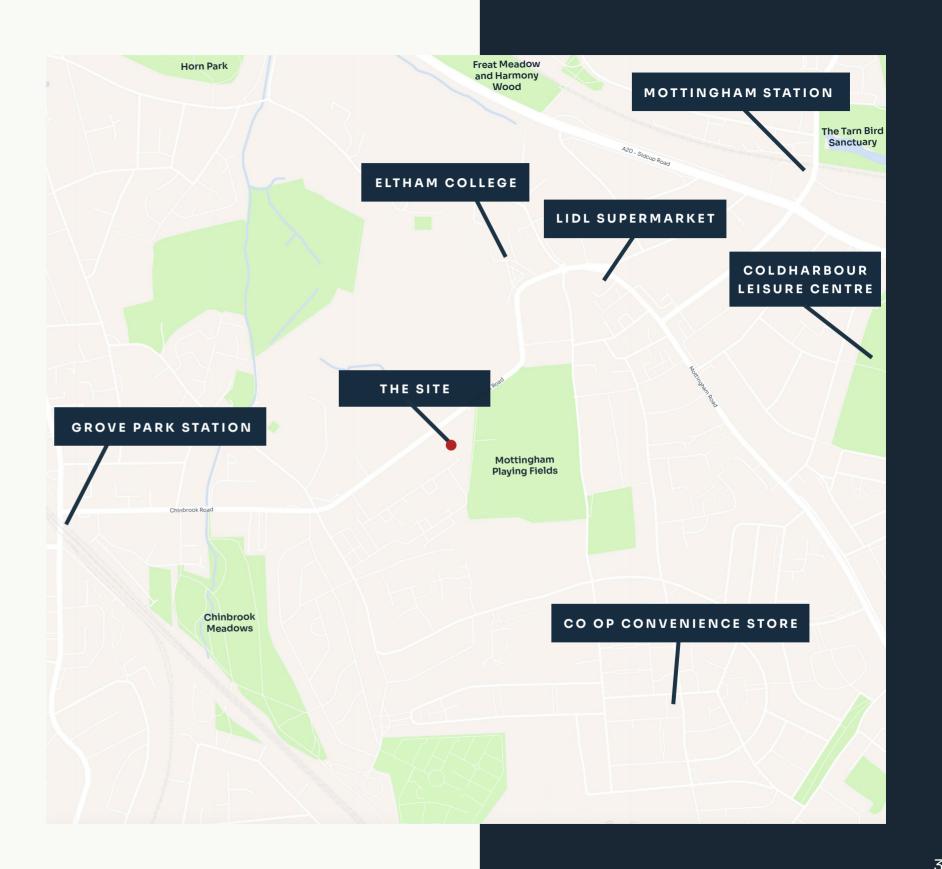

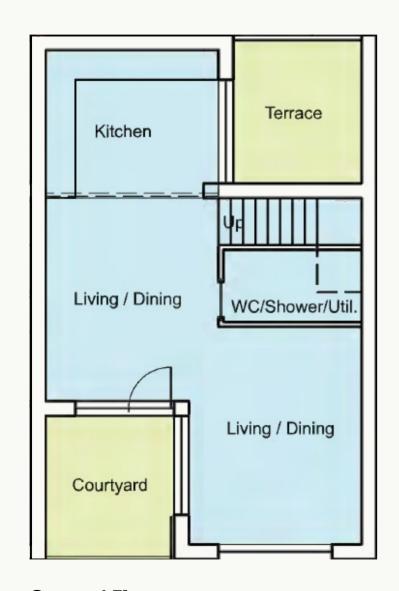

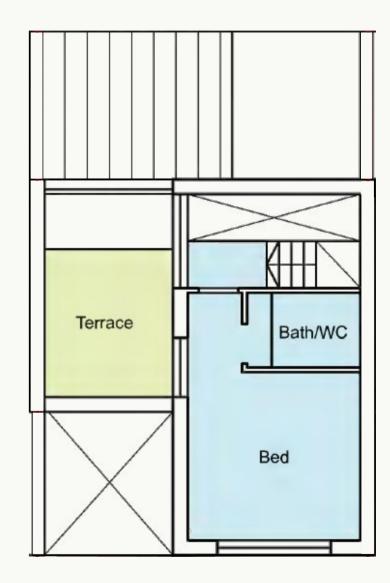
Proposed Floor Plans
