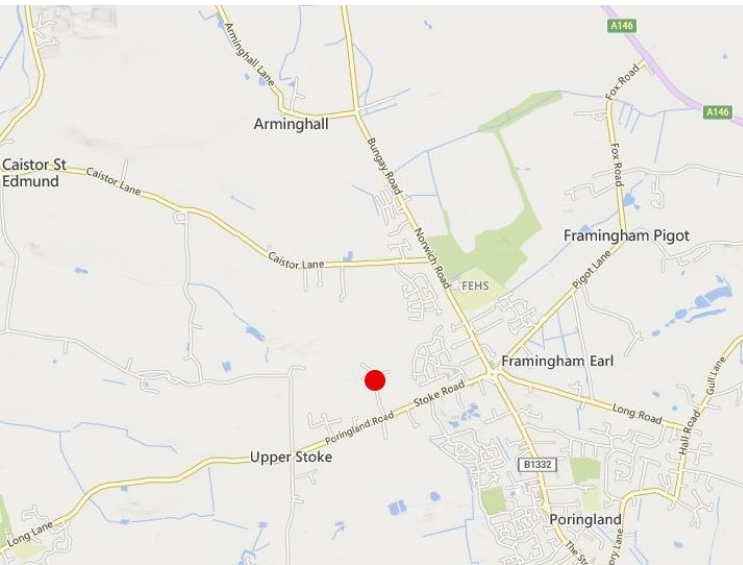

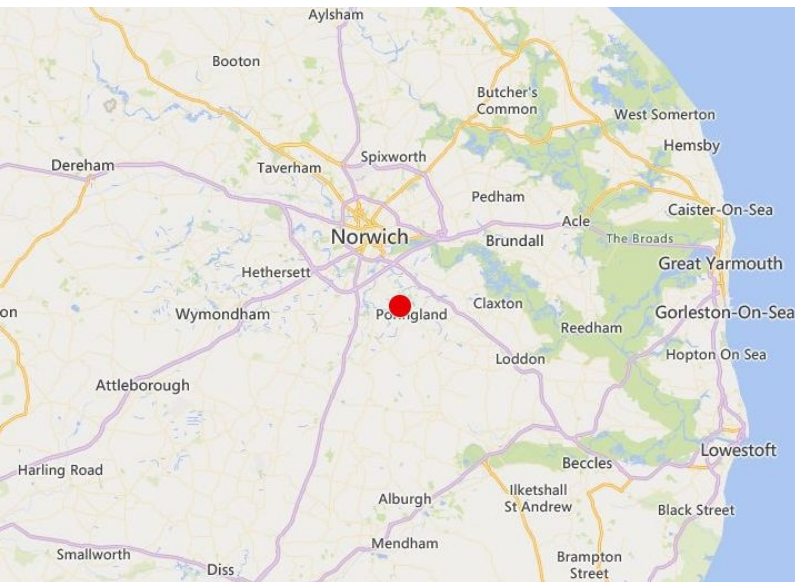
Description
