### **Description**

The property comprises an early 19th century Grade II listed former house. The property is now under mixed use with the ground and lower ground floors most recently used as an established antiques showroom, and the first floor continuing as a dental surgery.

Originally believed to have comprised two cottages, the accommodation on each floor includes a number of rooms with good floor to ceiling height and many fine period features throughout including hexagonal bay windows, feature fireplaces,

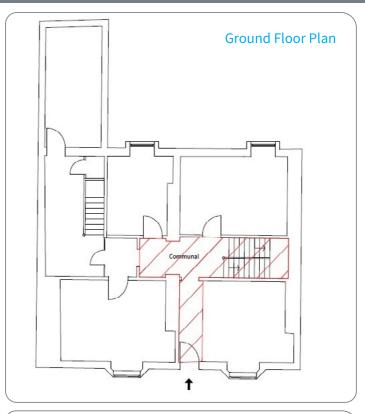


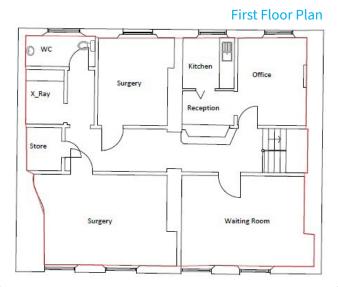

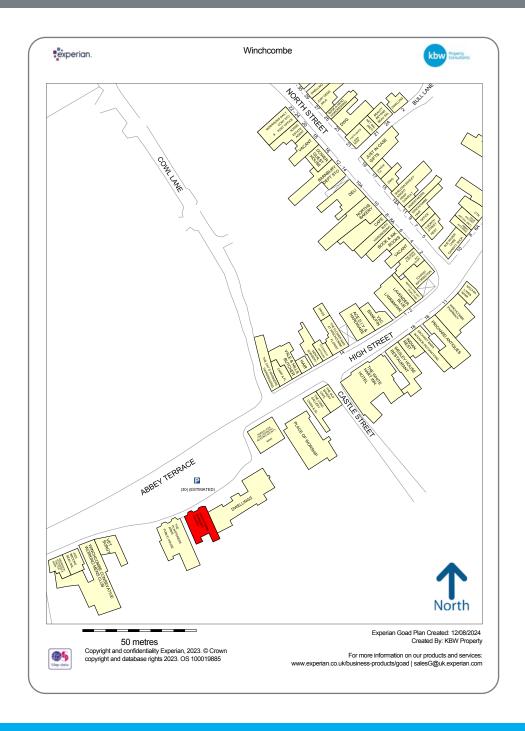
