Description

The units benefit from a roller shutter door, pedestrian entrance, three-phase electricity, LED lighting, internal offices and WC facilities. The units are of steel frame construction with elevations predominately of brick/blockwork and profile steel sheeting. The pitched roofs are clad in double skinned profiled sheeting incorporating translucent panels.

Access to the units are via steel roller shutter loading doors and pedestrian doors. Each unit has its own car parking area to the front.

The units can be let separately or combined.

Location

Tafarnaubach Industrial Estate in Tredegar lies approximately 2 miles north west of Rhymney, 7 miles east of Merthyr Tydfil and 4.4 miles north east of Ebbw Vale.

The A465 offers great transport links to South and West Wales and the Midlands (via the A40 24 miles to the east, leading to the M50). The A465 links with A470 at Merthyr and leads to J32 of the M4, 29 miles to the south and Cardiff.


