


Location

The property is situated towards the eastern end of Brentwood High Street on its southern side .

Brentwood High Street is a popular town offering a range of national and independent retailers, banks, restaurants and cafes. National retailers include Marks & Spencer, Boots, Superdrug, Holland & Barrett, Costa Coffee, Starbucks, Caffe Nero, Tesco and Sainsburys.

Brentwood rail station (Elizabeth Line) is within 10 minutes' walk from the property and the A12 & M25 within 10 minutes' drive.



Description

The property comprises a Grade II listed character building dating form the 18th century, currently used for the purposes of a bank and offices. It is situated over ground, first and second floors plus a basement. The property benefits from a private car park to the rear which is accessed from the High Street and can accommodate 11 or so cars.

The ground floor is the main banking area with first and second floors comprising offices, training rooms and staff facilities. The basement is used for storage.
