Location

Papworth Everard is a village situated approximately ten miles west of Cambridge and six miles south of Huntingdon. There is a local population of approximately 3,000 people. Amenities include a pharmacy, doctor's surgery, veterinary surgery, takeaway and library.

The property is located on Chequers Lane with a large private parking area for multiple vehicles to the front of the building.

Description

This is a rare opportunity to purchase the freehold interest in a former sports and social club benefiting from detailed planning consent for the demolition of the existing buildings and construction of a new cafe/restaurant. The new restaurant comprises a footprint of approximate 520 sq m (5,597 sq ft) and includes first floor restaurant accommodation and roof terrace.

Plans for the restaurant include stunning rooftop dining which will provide a unique alfresco experience with elevated panoramic views overlooking vibrant sports grounds which include cricket/tennis/football and bowls and attractive green spaces.

Accommodation

The total site area comprises approximately 0.25 acres. The planning permission details a building floor plate of approximately 520 sq m (5,597 sq ft). The existing buildings comprise an approximate gross internal area of 313 sq m (3,371 sq ft).

Planning

There is a detailed planning consent available for inspection on the South Cambridgeshire District Council planning portal under reference 24/03899/FUL. The permitted use is for a 'cafe/restaurant'.

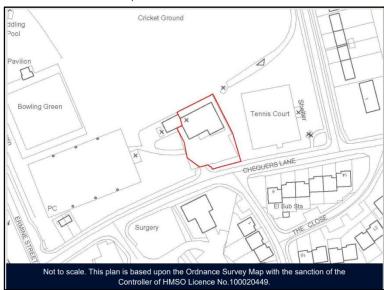
