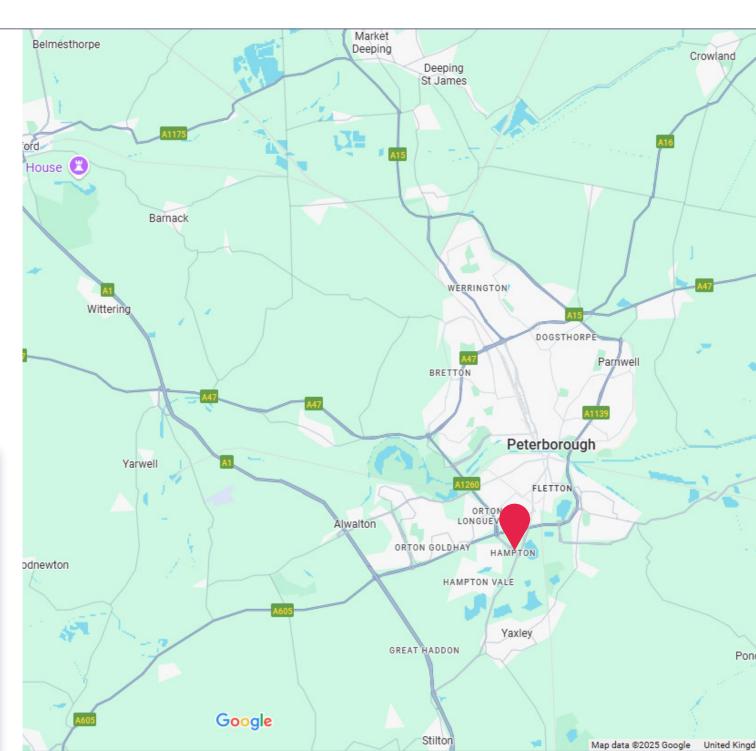
# Location
